- For the dirty water tank of water vacuums, cleaning machines and spray extractors

Product properties

- Foam reduction and prevention
- Makes the foam collapse spontaneously and prevents foam formation
- Economical consumption

Application and dosage

- Shake before use.
- Dosage depends on the foam development and corresponds to a concentration in the dirty water tank of approx. 1 - 5%.
- Add the product pure into the suction hose or, depending on the foam formation, 10 - 50 ml of defoamer per liter of dirt tank volume to the dirty water tank.
- Consumption: 1 - 4 ml / per application

- Apply fresh application solutions and consume them within 24 hours at the latest.

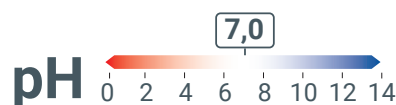
