Application and dosage

- Washing temperatures from 20 °C - 60 °C.
- For automatic and manual dosing. The recommended dosage depends on the amount of dirt, the water hardness and the load.
- When processing the laundry according to the VAH list: 1 ml Buz Laundry Color+ L 821 and 8 ml Buz Laundry Bright L 832 to 1 liter of liquor at 40 °C and 20 min. exposure time, liquor ratio 1:5.
